
Global E-Invoicing Service

What is the Global E-Invoicing Service?

E-invoicing (electronic invoicing) is the electronic exchange of structured invoice data between suppliers and customers, who can then process it automatically. Invoice data is transmitted either directly between sender and recipient via an e-invoicing network (e.g. Peppol) or central exchange and clearance systems (e.g. ChorusPro in France or SdI in Italy).

SEEBURGER's Global E-Invoicing Service is a cloud-based B2B service designed to support any company exchanging electronic invoice data in an international environment. International e-invoicing is often subject to strict requirements on how the invoice is created and delivered, with real-time checks and approval of transactions by authorities or government-appointed companies.

Our out-of-the-box country-specific e-invoicing services enable you to get started quickly – regardless of where your international business partners are based or what technology they use.




Overview


